CERTIFICATE OF LOCATION

LODE CLAIM

THIS IS TO CERTIFY that the CT 1313 lode mining claim was located by:

St. George Metals, Inc.

on the 10 day of Nov, 1988, situated in the undesignated Mining District,
Eureka County, State of Nevada.

Said claim is located in the NE/4 of Sec. 34, Twp. 33 North, Range 50 East.
SE/4 of Sec. 34, Twp. 33 North, Range 50 East.
NW/4 of Sec. 34, Twp. 33 North, Range 50 East.
SW/4 of Sec. 34, Twp. 33 North, Range 50 East.

To tie this claim to the Public Survey, begin at the SW corner of Section
34, Township 33 North, Range 50 East, Mount Diablo Meridian,
thence 4800 feet E and 3780 feet N to the Northeast
corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein,
extending 50 feet from the location monument in a N direction
and 1450 feet in a S direction, together with 300 feet
on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial PVC Pipe
monuments firmly set in the ground and bearing applicable monument designation. The
description of such claim is: Beginning at the Northeast Corner:

thence, <u>W</u> , <u>600</u> feet to the <u>NW</u> corner,	
thence, <u>S</u> , <u>750</u> feet to the <u>W</u> side center,

the point and place of beginning.

The monumentation and marking of the corners was completed by the 7 day of
Jan, 1989.

the lode claim filing fee has been paid to the County Recorder.
