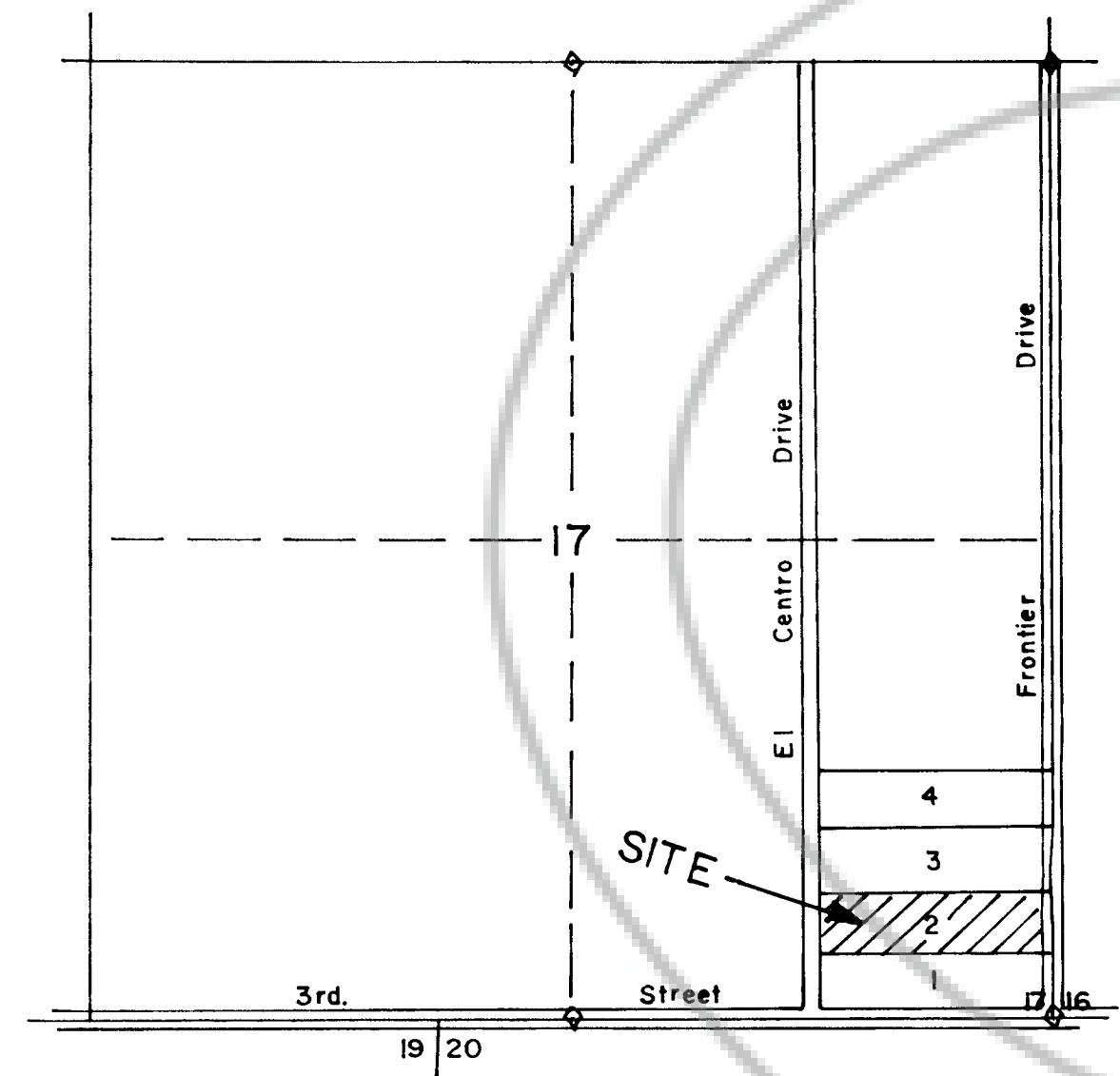
SURVEY NOTE
 Due to finding original monuments at the SE corner and the S. 1/4 corner of Section 17 that were not found nor used on the survey for the Large Division Map of the East 1/2 of Section 17 (Document No. 81925), subsequent parcel maps and corners set thereby, this data could not be used for this survey except for the concept of lot size and shape and the location of streets and street easements. The entire discrepancy was placed on a single lot (Lot 2 of Parcel "B") in order to protect previously sold lots with the concurrence of the owner of Lot 2 of Parcel "B."
