Dear Earl and Kenneth:

This Letter Agreement will confirm our mutual understanding and intent regarding Westmont Mining Inc.'s ("Westmont") exercise of its purchase option pursuant to the referenced agreement. Under the agreement, Westmont gave notice to you by letter dated August 26, 1988, that Westmont elected to exercise its option to purchase the Big Six Property and to pay you the \$40,000 balance of the purchase price.

At your request, Westmont agreed to offer a limited production royalty on the Big Six Property as an alternative to some or all of the cash balance due. You elected to take \$30,000 in cash now, plus a one percent (1%) Net Smelter Return production royalty on the property to a maximum of \$50,000, in lieu of the \$40,000 in cash originally provided for in the referenced agreement which Westmont offered to pay.

You expressly acknowledge and agree that Westmont has not represented to you that any mineable ore reserves exist on the Big Six Property or that Westmont has any plans to place the Big Six Property into production. You further acknowledge that the decision to retain a production royalty was your decision and was not induced by any representations or commitments made by Westmont concerning the Big Six Property.

In witness whereof you and Westmont have executed this Letter Agreement as of this 28<sup>th</sup> day of September, 1988.
