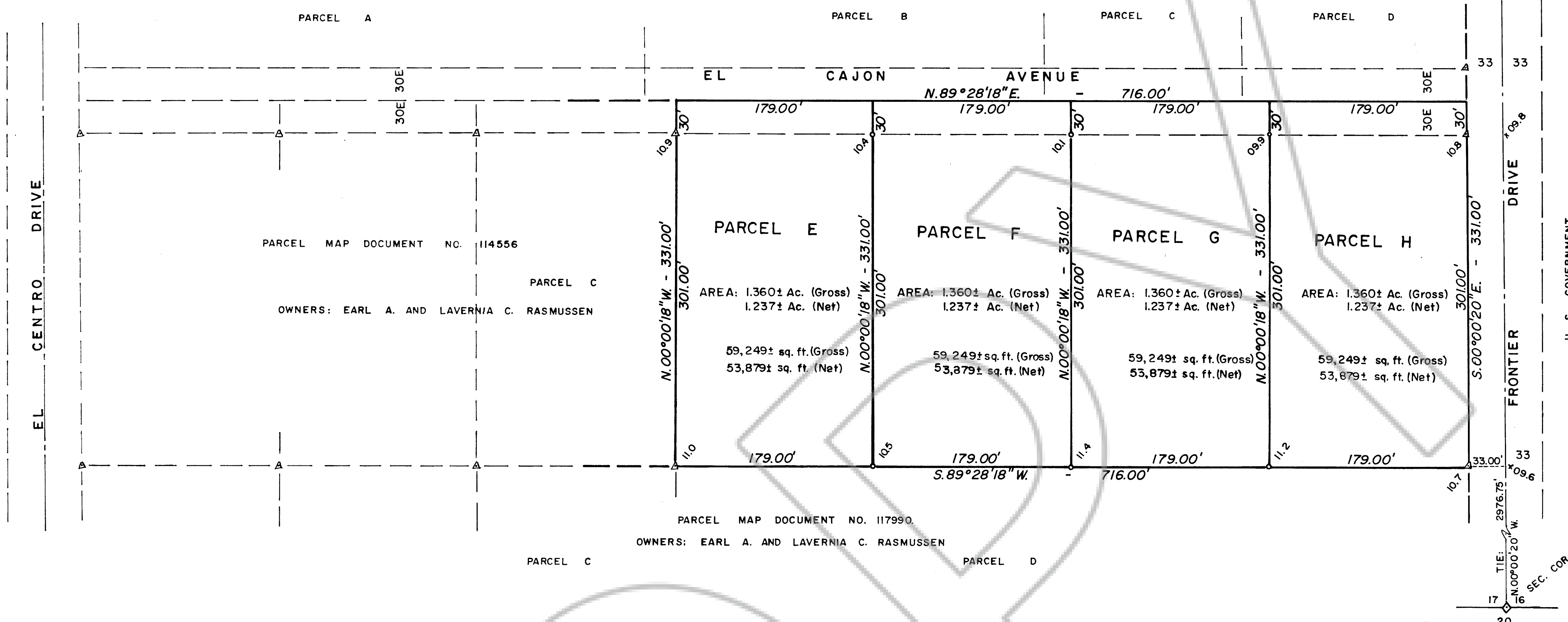

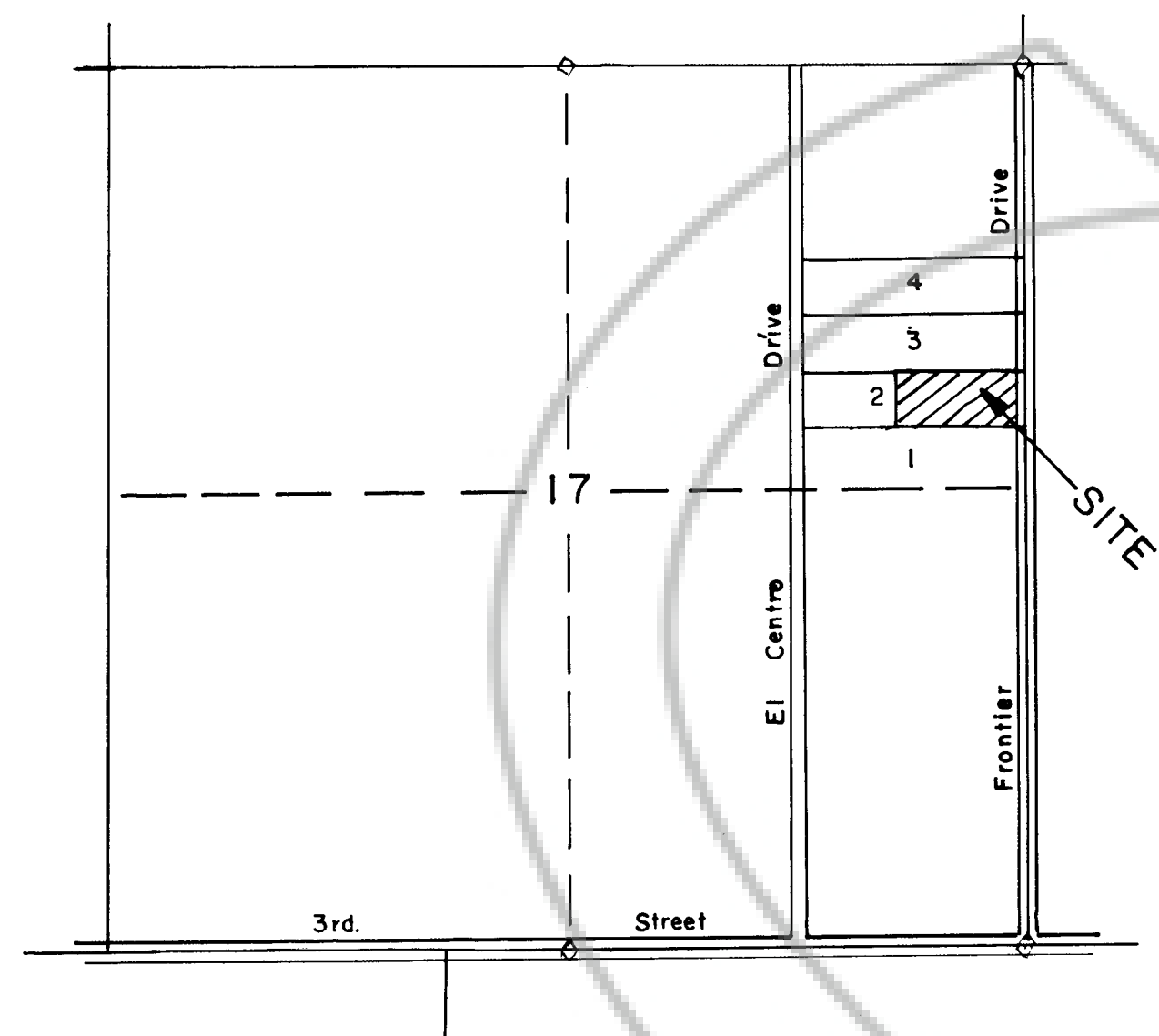
**COUNTY COMMISSIONER'S APPROVAL**
