CERTIFICATE OF LOCATION

NOTICE IS HEREBY SIVEN that BHP Minerals International Exploration Inc., 5330 South 975 East, Salt Lake City, a Telaware corporation, hereby claims under and pursuant to the laws of the State of Nevada and of the laws of the United States of America the following describe: LODE MINING CLAIM:

The name of the claim is SB #111. This claim was located on the 14th day of December 1994, by posting a Location Notice at the discovery monument found at, on or near the NE End Center

The length of the claim is 1480 feet in a SW direction and 20 feet in a BE direction from the monument where the Location Notice is posted, and the width is 300 feet on each side of the center of the vein or lode, comprising in all 1500 feet in length and 600 feet in width, and generally following a BE to SW course.
