No. 6: <u>Center line</u>	<u>Post 24" x 4" x 4"</u>	<u>White Plastic Pipe 3" dia. 5' long</u>

As erected on the ground, each side center or corner monument is marked as described above by (e.g. metal tags, paint on posts).
