I, Jon P. Broderick, President of BRR Resources, Inc.,
hereby depose and state as follows:

1. On June 23, 1988, Resource Associates of Alaska, Inc.,
now known as NERCO Exploration Company ("NERCO"), located the
following described mining claims within Township 20 North, Range
51 East, M.D.B.&M., Eureka County, Nevada:

2. NERCO failed to erect corner and side-center posts within the sixty days following location as required by Section 517.030 of the Nevada Revised Statutes;

3. That following such failure, BRR Resources, Inc. located the BRR 193 through 224 mining claims within Sections 4, 5, 8, 9, 16 and 17 of said Township 20 North, Range 51 East, as more specifically provided on the claim map recorded in the office of the Eureka County Recorder on November 17, 1988, as Document No. 124857, and also filed with the Bureau of Land Management. The BRR locations are identified as NMC No. 526855 through 526886.

4. NERCO subsequently, on February 13, 1989, transferred to BRR any and all of its right, title and interest in and to the above-described LS locations, a recorded copy of which is found at Book 195, Page 402, Official Records of Eureka County;

5. That BRR hereby gives notice that the LS locations were void ab initio and that said locations are hereby abandoned and declared null and void as if they had never been located;

6. That as a result of said invalidity of the LS locations, the BRR claims described herein constitute the senior valid and existing locations as against the attempted locations of the LS claims.

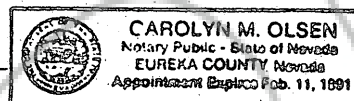
