FULL RECONVEYANCE

FIRST AMERICAN TITLE COMPANY OF NEVADA ("Trustee"), a duly appointed Trustee under that certain Mortgage, Deed of Trust, Security Agreement, and Financing Statement dated as of February 23, 1988, as amended by the First Amendment to Mortgage, Deed of Trust, Security Agreement, and Financing Statement dated as of August 11, 1988, and as further amended by that certain Notice of Change of Name, Merger and Termination of Joint Venture, and Amendment of Mortgage, Deed of Trust, Security Agreement, and Financing Statement dated March 13, 1989 (collectively the Mortgage, Deed of Trust, Security Agreement and Financing Statement, and the two amendments described above are referred to as the "Deed of Trust"), having received from the holder of the obligations under the Deed of Trust a written request to reconvey all of the estate held by Trustee under the Deed of Trust, does hereby RECONVEY without warranty to the person or persons legally entitled thereto all of the estate now held by the Trustee under the Deed of Trust.

in the UCC Records as File No. 1217 of the Records of Eureka County, Nevada, and was recorded on February 24, 1988, at Book 605, Page 575, and filed in the UCC Records as File No. 11312 of the Records of Elko County, Nevada, and was filed on February 24, 1988 as Uniform Commercial Code File Nos. 88-01917, 88-01918, 88-01920 with the Nevada Secretary of State, and was amended by that certain First Amendment to Mortgage, Deed of Trust, Security Agreement, and Financing Statement dated as of August 11, 1988, and recorded September 15, 1988 at Book 184, Page 140, and filed in the UCC Records as File Nos. 1243 and 1248 of the Records of Eureka County, Nevada, and was further amended by that certain Notice of Change of Name, Merger and Termination of Joint Venture, and Amendment of Mortgage, Deed of Trust, Security Agreement, and Financing Statement dated March 13, 1989, and recorded with the Eureka County Recorder's Office on March 17, 1989 in Book 195, Page 292, and recorded with the Elko County Recorder's Office on March 17, 1989 in Book 669, Page 417, and was filed March 20, 1989 in the UCC Records of Eureka County, Nevada as File Nos. 1217, 1243, and 1248, and filed on March 20, 1989 in the UCC Records of Elko County, Nevada as File No. 11312.

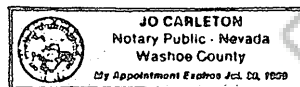
