G. Andrikopoulos to Marathon Oil Company (50%) and Pennzoil Exploration and Production Company (50%) as it applies to his interest and the interest of A. G. Andrikopoulos.

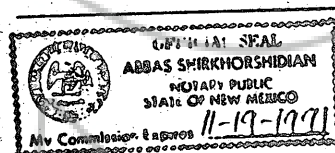
