The claim is 1500 reet long and 500 reet wide, and 15 feet is claimed in a SOUTHERLY direction and 1275 feet in a NORTHERLY direction from the Discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and the premises is from the North to the South.
