

# — CERTIFICATE OF LOCATION —

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has have located the SWC # 45 Lode Mining Claim in the NW quarter of Section 18, NE 1/4 S 13 (24) SE 1/4 S 12 (24) SW 1/4 S 7 Township 34 North, Range 30 East, Mount Diablo Base & Meridian, in an Unknown Mining District, Eureka County, in the State of Nevada, on the 11th day of February, 1989.

The Discovery Monument bears 4145 feet North, and 200 feet East from the Southwest corner of Section 18.

The claim is 1500 feet long and 200 feet wide, and 15 feet is claimed in a SOUTHERLY direction and 1475 feet in a NORTHERLY direction from the Discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and the premises is from the North to the South.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by 3"x 5" aluminum tags attached to the posts with wire.

The description of each corner is as follows:

Corner No. 1 is a 3" diameter x 5' long P.V.C. post  
Corner No. 2 is a 3" diameter x 5' long P.V.C. post  
Corner No. 3 is a 3" diameter x 5' long P.V.C. post  
Corner No. 4 is a 3" diameter x 5' long P.V.C. post  
Corner No. 5 is a 3" diameter x 5' long P.V.C. post  
Corner No. 6 is a 3" diameter x 5' long P.V.C. post

All corner posts are wired to 1/2"x24" rebar set 12" in ground.

The monumentation and marking of the corners was completed by the 14th day of February, 1989.

The location work consisted of making a map as provided in NRS 517.040. Two copies of this map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
