I

The name of the corporation is:

Nevada Right to Life. (Not amended)

II

This corporation is a non-profit corporation, organized solely for educational and general charitable and eleemosynary purposes. (Not amended)

III

The purposes of the corporation are to:

(a) Present fully detailed and factual information upon which individuals and the general public may make an informal decision about the various topics of unborn child development, abortion, alternatives to abortion, euthanasia and infanticide. (Not amended)

(b) Improve and further personal and social responsibility for human life. (Not amended)

(c) Foster and increase protection of the right to life of mother and child. (Not amended)

(d) Inform the public on abortion, euthanasia and other related subjects. (Not amended)

(e) Foster high standards of medical care in the State of Nevada. (Not amended)

(f) Promote and encourage assistance in the care and rearing of children. (Not amended)

(g) Promote enlightened care and assistance to mother and child, including the unborn child, in difficult, unwanted or born out of wedlock pregnancies. (Not amended)

(h) Cause to be published and to distribute treatises, articles, addresses, reports and other publications on any and all subjects hereinabove stated to any and all persons. (Not amended)

(i) Aid and assist individuals, corporations, associations and institutions now or hereafter engaged in furthering any one or more of the aims hereinabove set forth and do such other things as may be necessary or proper to carry out any of the foregoing aims of the corporation. (Not amended)

(j) Receive, manage and use any property, real, personal or mixed, acquired by the corporation by gift, bequest, purchase or otherwise, for the purposes and objects of the corporation, provided, however, that no part of the net earnings of this corporation shall inure to the benefit of any member or individual. (Not amended)

Notwithstanding the foregoing statements of the purposes, this corporation shall not engage in any activity which is not permitted to be engaged in by a corporation exempt from federal income tax under Section 501(c)(4) of the Internal Revenue Code of 1954 as amended. (Amended 1/10/88)

IV

The address of the corporation is 180 West First Street, Suite 4, Reno, Nevada 89501. (Not amended)

V

The governing body of this corporation shall be known and designated as the Board of Trustees. There shall be not less than three (3) nor more than fifteen (15) trustees. The exact number of Trustees shall, within these limits, be set by the Board. The Board shall be elected by the members at the Annual Meeting of members, in a manner provided in the By-Laws of the corporation. Each trustee shall hold office for term of three (3) years, or until his or her successor has been selected or appointed. Trustees may be re-elected to the Board. The terms of office of the trustees shall be established in such a manner that only approximately one-third (1/3) of said trustees' terms expire in any one year. In the event of a change in the number of trustees, the staggering of terms will be preserved.

Subject to the limitations of these Articles of Incorporation, and the By-Laws of this corporation and the laws of the State of Nevada, corporate powers shall be exercised by and under the authority of, and the business and affairs of this corporation shall be controlled by the Board of Trustees.(Not amended)

In the event that this corporation shall be dissolved or wound up at any time, then all of the properties, monies and assets of this corporation remaining after provision has been made for the payment of its known debts and liabilities as provided by law, shall be transferred exclusively to and become the property of such non-profit funds, foundations or corporations as are selected and designated by the members of this corporation, and which shall at that time qualify as an exempt organization or organizations under 501(c)(4) of the Internal Revenue Code of 1954, as that section exists, with preference for distribution to a tax exempt organization having similar charitable objectives to those of this corporation. 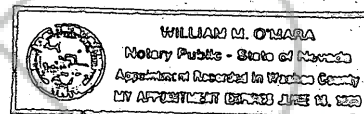
