FINDINGS OF FACT

That all of the allegations of Plaintiff's complaint are true.

That the Court has jurisdiction over the parties and the cause of action, and to hear and determine the same.

CONCLUSIONS OF LAW

That the Plaintiff is entitled to the relief hereinafter granted.

DECREE OF DIVORCE

By reason of the premises, IT IS HEREBY ORDERED, ADJUDGED 12 AND DECREED:
