NOTICE AND CLAIM OF LIEN

NOTICE IS HEREBY GIVEN that COLUMBIA ENGINEERING CORPORATION claims a Mechanic's and Materialman's Lien upon the property hereinafter particularly described; which property is located in Eureka County, Nevada, and which claim is made pursuant to the laws of the State of Nevada, particularly Chapter 108 of the Nevada Revised Statutes, as amended, for the value of work, labor, materials and/or services furnished by lien claimant for the improvement of real property hereinafter particularly described, located in the County of Eureka, State of Nevada.

That the whole or real property hereinafter particularly described has been or is in the process of improvement and is reasonably necessary for the convenient use and occupation of said property.

Claimant further states:

1. That the name of the owners or reputed owners of the premises sought to be charged are ATLAS GOLD MINING and ATLAS PRECIOUS METALS, INC.
2. That the name of the person by whom lien claimant was employed and to whom lien claimant furnished work, labor, materials and/or services in connection with the project is ATLAS PRECIOUS METALS, INC.
3. That the terms, time given and conditions of the contract were: Lien claimant agreed to modify and expand an existing gold processing facility for the contract price of \$3,174,10.78. The scope of the work included demolition, relocation of equipment, structural steelwork, fabricated items, excavation, concrete foundations, civil work, mechanical installation including the drilling of holes for the installation of the equipment, process and service piping, electrical and instrumentation, architectural finishes, building services, testing and pre-commissioning. Lien claimant incurred additional costs of \$1,892,873.00 during the course of construction as a result of loss of productivity, delay, acceleration, and interference. All such costs were incurred in performing the contract, and are justly due lien claimant.
4. That work, labor, materials and/or services have been furnished to and actually used upon the above-described project in the total amount of \$5,067,583.48 Dollars, plus interest accrued on unpaid sums.

5. That a demand for payment has been made by lien claimant. \$2,857,300.48 of the amount due and owing has been paid. There are no further off-sets to the claim and that the sum of \$2,210,283.00 dollars, plus interest, is now due and owing to lien claimant on account of the work, labor, materials and/or services furnished as above specified. The undersigned claims a lien upon the real property particularly described herein for said sum, together with interest and attorney's fees as provided by law.

6. That the real property sought to be charged with this Claim of Lien upon which the above described work of improvement has been made is located in the County of Eureka, State of Nevada, commonly known as the Gold Bar Mine and particularly described on Exhibit "A" attached hereto and incorporated herein by this reference.

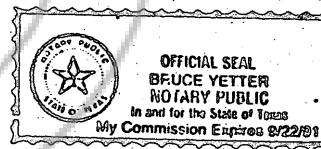
