**CERTIFICATE OF LOCATION**

NOTICE IS HEREBY GIVEN, That the undersigned, having complied with the requirements of Chapter Six, Title thirty-two of the Revised Statutes of the United States, and the laws of the above State, and the local customs and regulations of said district,

has located and do hereby locate 1500 linear feet in length,  
and 600 feet in width on the PETE 254

lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District, and further described as follows: Commencing at a post marked SW corner located about 300' South from the monument of location thence 750 feet in a N 70° East direction to a post marked south side center, thence 750 feet in a N 70° East direction to a corner post marked SE cor., thence 600 feet in a Northerly direction to a corner post marked NE Cor., thence 750 feet in a S 70° West direction to a post marked Northside center, thence 750 feet in a S 70° West direction to a corner post marked NW Cor., thence 600 feet in a Southerly direction to the SW corner hereby locating and intending to claim 1450 feet in a Easterly direction from Monument of location to the East end line, and 50 feet in the opposite direction from discovery to the West end line, and 300 feet on each side of the middle of said lode or ledge for the purpose of mining the same and claiming all surface rights, privileges and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs. This claim is further described as follows: The Monument of Location of this claim is approximately 3900 ft. southerly and 5100 ft. westerly of the NE corner of Section 36 Township 28 N, Range 52 E. Nevada Meridian, Eureka County, Nevada.

The adjoining claims are on the north; Pete 253 on the south; on the west; Pete 269 on the east.

The location work consisted of making & preparing maps as required in Nevada Revised Statutes 517:040. A notice of location is placed at Location Monument; Posts are placed at each corner at the center of each side line and the name of this lode and date of location, are placed on all posts.
