NOTICE IS HEREBY GIVEN, That the undersigned, having complied with the requirements of Chapter Six, Title thirty-two of the Revised Statutes of the United States, and the laws of the above State, and the local customs and regulations of said district,

has located and do hereby locate 1500 linear feet in length,
and 600 feet in width on the PETE 276

lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District, and further described as follows: Commencing at a post marked SE corner located about 300' east from the

monument of location, thence 750 feet in North erly
direction to a Eastside center post marked, thence 750 feet in Northerly
direction to a corner post marked NE corner, thence 600 feet in Westerly
direction to a corner post marked NW corner, thence 750 feet in Southerly
direction to a post marked Westside Center, thence 750 feet in Southerly
direction to a corner post marked SW corner, thence 600 feet in Easterly

feet in a northerly direction from monument of location to the north
end line, and 140 feet in the opposite direction from discovery to the
