has located and do hereby locate 1500 linear feet in length,

and 600 feet in width on the PETE 404

lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District, and further described as follows: Commencing at a post marked SE corner located about 300' southerly from the monument of Location, thence 550 feet in a S 80° Westerly
