## CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN, That the undersigned, having complied with the requirements of Chapter Six, Title thirty-two of the Revised Statutes of the United States, and the laws of the above State, and the local customs and regulations of said district,

has located and do hereby locate 1500 linear feet in length, and 600 feet in width on the PETE 407

lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District, and further described as follows: Commencing at a post marked SE corner located about 300' southerly from the monument of Location, thence 550 feet in S 80° Westerly direction to a Southside center post marked, thence 550 feet in S 80° Westerly direction to a corner post marked SW corner, thence 600 feet in Northerly direction to a corner post marked NW corner, thence 750 feet in N 80° Easterly direction to a post marked Northside center, thence 750 feet in N 80° Easterly direction to a corner post marked NE corner, thence 300 feet in Southerly direction to the SE corner hereby locating and intending to claim 1,050 feet in a Westerly direction from monument of location to the West end line, and 50 feet in the opposite direction from discovery to the
