The claim is 726 feet long and 600 feet wide, and 10 feet is  
claimed in a East direction and 716 feet in a West direction from the  
location monument, at which the Notice of Location is posted, lengthwise of the claim,  
together with 300 feet in width on each side of the center of the claim.

The general course of the placer deposit and premises is from East to the  
West. The area claimed in this location is 10 acres.

The location and number of each corner of this claim is shown on the claim map  
that is filed herewith. On the ground, each corner of the claim is marked with its  
appropriate number by marking the claim name and number on an aluminum tag.

The description of each corner is as follows:

Northwest Corner No. 1 is a 3" X 4 ft. PVC pipe.  
North Side Center No. 2 is a 3" X 4 ft. PVC pipe.  
Northeast Corner No. 3 is a 3" X 4 ft. PVC pipe.  
Southeast Corner No. 4 is a 3" X 4 ft. PVC pipe.  
South Side Center No. 5 is a 3" X 4 ft. PVC pipe.  
Southwest Corner No. 6 is a 3" X 4 ft. PVC pipe.

The monumentation and marking of the corners was completed by the 16th day  
of June, 1989. This claim is intended to cover all land open to  
location existing within its boundaries as of this date of posting. The locator does  
not intend to acquire any lodes that may exist and may be held by valid lode mining  
claims.

The location work consisted of making a claim map as provided in NRS 517.040.  
Two copies of this claim map have been filed with the Eureka County  
Recorder, and the required placer claim filing fee has been paid to the County Recorder.
