CERTIFICATE OF LOCATION

LODE CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has caused to be located the CAN # 167 lode mining claim on the 23rd day of June, 1989.

Said Claim is located in the NE/4 of Sec. 10, Twp. 15 North, Range 52 East;
SE/4 of Sec. 10, Twp. 15 North, Range 52 East;
NW/4 of Sec. 10, Twp. 15 North, Range 52 East;
SW/4 of Sec. 10, Twp. 15 North, Range 52 East;
Mount Diablo Base and Meridian, Eureka County, Nevada.

To tie this claim to the Public Survey, begin at the SW corner of Section 36, Township 16 North, Range 52 East, Mount Diablo Meridian, thence 5900 feet South and 7000 feet West to the Northeast corner of this claim.

The general course of the lode or vein is North to South.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein, extending 10 feet from the location monument in a Northerly direction and 1490 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial PVC Pipe monuments, firmly set in the ground and bearing applicable monument designation. The description of such claim is: Beginning at Corner No. 1, the Northeast Corner:

thence, South 750 feet to the Eastside center (No. 2), a 3" in dia. by 5' in length PVC pipe;
thence, South 750 feet to the Southeast corner (No. 3), a 3" in dia. by 5' in length PVC pipe;
thence, West 600 feet to the Southwest corner (No. 4), a 3" in dia. by 5' in length PVC pipe;
thence, North 750 feet to the Westside center (No. 5), a 3" in dia. by 5' in length PVC pipe;
thence, North 750 feet to the Northwest corner (No. 6), a 3" in dia. by 5' in length PVC pipe;
thence, East 600 feet to the Northeast corner (No. 1), a 3" in dia. by 5' in length PVC pipe;
the point and place of beginning.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
