The Petition of THOMAS J. TOMERA and PATSY SUE TOMERA, Guardians of the Person and Estate of GEORGE TOMERA, filed in this Court on June 21, 1989, praying for authority to execute that certain Mining Lease with RIO ALGOM EXPLORATION, INC., and three (3) Oil and Gas Leases with LOMA ENERGY CORP., and requesting this Court's advice and instructions regarding certain charitable contributions and expenditures; the hearing having been set for Monday, July 10, 1989, at the hour of 9:00 A.M. of said day, at the Elko County Courthouse, Elko County, Nevada; the matter having come on regularly for hearing at said time and place, and it appearing that due notice of said hearing has been given as required by law, as more fully appears from the Affidavit of mailing on file herein, together with certified mail receipts, which are hereby referred to and made a part hereof; the Court

1 having heard testimony in support of the Petition, the Court finds
2 as follows:

A. RIO ALGOM EXPLORATION, INC., has presented to the Guardians a Mineral or Mining Lease on terms and conditions which are beneficial to the Guardianship, providing rental and royalty income to the Guardianship. The property subject to the Lease is located in Elko County, Nevada and concerns Sections 5, 7, 17, and 21 of Township 31 North, Range 53 East, M.D.B.&M. The terms of the Lease are advantageous to the Guardianship; the primary term of the Lease is a period of fifteen years, and for so long thereafter as minerals shall be produced on the property, but not longer than thirty years. The proposed Lease provides for a graduated advance minimum royalty payable through the term of the Lease unless production royalties are paid; the Lease is terminated by non-payment of the advance royalty; the Guardians should be authorized to execute this Lease.

B. LOMA ENERGY CORP., has presented the Guardians with three Oil and Gas Leases on terms and conditions which are beneficial to the Guardianship's estate providing rental and royalty income. The property subject to the Oil and Gas Lease is located in both Eureka and Elko Counties; the terms of each Lease are advantageous to the Guardianship; the primary term of each Lease is five years and for as long thereafter as oil and gas are produced; the Guardians should be authorized to execute all three 25 Oil and Gas Leases.

26 C. The Guardians have petitioned this Court concerning vertain charitable contributions and expenditures. Petitioners

believe that certain charitable contributions will be in the Ward's best interest, and request advice and instructions authorizing the donation of (a) \$5,000.00 to the Baptist Church in Carlin, for a sprinkler system and other exterior improvements; (b) \$25,000.00 to the Catholic Church for the purpose of erecting a community center building; (c) for purchase of a portable stage for Carlin High School; and (d) to allow the Guardians to contribute up to \$10,000.00 to other charities during 1989. The Guardians have further asked this Court for authority to employ a ranch hand for \$1,000.00 per month to care for the Ward's livestock, and for authority to pay the Guardians a reasonable monthly fee for the care of the person of the Ward and for care and management of his estate in the sum of \$2,000.00 per month, commencing from March 2, 1989.

D. The Court hereby finds all proposed leases, activities and payments to be reasonable and appropriate under the circumstances.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that:

19 1. The Guardians are authorized to enter into a Mineral or
20 Mining Lease in favor of RIO ALGOM EXPLORATION, INC., on the
21 terms and conditions described and for a period of fifteen years
22 or, as long thereafter as minerals shall be produced, but not
23 exceeding thirty years.

24 2. The Guardians are authorized to enter into three Oil 25 and Gas Leases in favor of LOMA ENERGY CORP., on the terms and 26 conditions described and for a period of five years or as long 27 thereafter as oil and gas shall be produced.

The Guardians are instructed to make the following charitable contributions. (a) To Carlin Baptist Church, the sum of \$5,000.00; (b) to Carlin Catholic Church, the sum of \$25,000.00; and (c) to Carlin High School, the sum necessary to purchase a portable stage. 4. The Guardians are authorized to make such additional charitable contributions during 1980, in a total sum not to exceed \$10,000.00 as the Guardians shall deem necessary and appropriate. 5. The Guardians are instructed to employ a ranch hand at 12 \$1,000.00 per month to feed and care for the Ward's livestock and 13 to pay the Guardians \$2,000.00 per month from March 2, 1989, for 14 the care of the Ward and care and management of the Ward's estate. 6. The Guardians are instructed to record a certified copy 16 of this Order in the Official Records of Elko County, Nevada and in Official Records of Eureka County; Nevada.
