17 party to any matters whatsoever.

19 undersigned do hereby assign, transfer and set over unto said
20 NEWMONT GOLD COMPANY and BECHTEL CONSTRUCTION COMPANY, as
21 contractors, its above-mentioned claim against LORD ELECTRICAL
22 COMPANY, INC., as subcontractor, and the undersigned constitute
23 said assignee, its true, lawful and irrevocable attorney to
24 demand, receipt for and enforce payment of said claim, at its own
25 expense to sue for said sum so assigned either in the name of
26 the undersigned or its own name.


