 and 600 feet in width on the O.P. #20

lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District, and further described as follows: Commencing at a post marked SE corner located about 300' east from the monument of location, thence 750 feet in a Northerly direction to a Eastside center post marked, thence 750 feet in a Northerly direction to a corner post marked NE corner, thence 600 feet in a Westerly direction to a corner post marked NW corner, thence 750 feet in a Southerly direction to a post marked Westside Center, thence 750 feet in a Southerly direction to a corner post marked SW corner, thence 600 feet in a Easterly direction to the SE corner hereby locating and intending to claim 1450 feet in a northerly direction from monument of location to the north end line; and 50 feet in the opposite direction from discovery to the south end line, and 300 feet on each side of the middle of said lode or ledge, for the purpose of locating the same and claiming all surface rights, privileges and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs.
