That on the 27<sup>th</sup> day of April, 1989, the above lode mining claim was duly located in the Buckhorn Mining District, Eureka County, Nevada.

The locator hereby claims 1780 feet in a N83°E direction and 20 feet in a S83°W direction from the location monument and 300 feet on each side of said lode or vein. The general course of this claim is N83°E-S83°W.

That the following reference is hereby made to natural objects and permanent monuments so as to identify said claim, to wit:

The discovery monument is located approximately 7030 feet in a S5°W direction from United States Land Monument #228  
(USLM #228)

Within 20 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 4 x 4 inch wooden posts, native timber, 4 inch diameter PVC pipe or rock monuments. Each monument is marked with the name of the claim and a diagram or statement indicating its location. Location work consisted of making the maps in accordance with NRS 517.040, which are recorded herewith.
