

As erected on the ground, each corner and sideline center monument consists of a wooden post at least 31 inches in diameter by 4 feet in length set one foot in the ground and is marked as post det least 3 inches in diameter by 4 feet in length set one foot in the ground and is marked as described above by an aluminum tag attached to the monument.
