MERKINGS ON METAL TAG

 If metal post used, it must be at least 2 inches in diameter. If a durable plastic pipe is used, it must be at least 3 inches in diameter.

 Posts may also be scribed or marked giving the claim name, monument number, and position. The claim map must be at a scale of not less than 500 feet to the inch, which sets forth the position of the monuments in relation to each other and establishes numbers of boundary monuments. The size of each sheet must be 24 m 32 inches.
