To tie this claim to the Public Survey, begin at the NORTHEAST corner of Section 11, Township 35 N, Range 50 E, Mount Diablo Meridian, thence 1680 feet WEST and 2100 feet SOUTH to the northeast corner of this claim.

I claim 1500 linear feet along the course of the ledge, lode or vein, extending 900 feet from the location monument in a NORTHEAST direction and 600 feet in a SOUTHEAST direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 4" x 4" wood monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is: Beginning at the Northeast Corner:

thence, <u>SOUTH</u> , <u>750</u> feet to the <u>EAST</u> side center,
thence, <u>SOUTH</u> , <u>750</u> feet to the <u>SOUTHEAST</u> corner,

thence, <u>NORTH</u> , <u>750</u> feet to the <u>WEST</u> side center,
thence, <u>NORTH</u> , <u>750</u> feet to the <u>NORTHWEST</u> corner,
thence, <u>EAST</u> , <u>600</u> feet to the <u>NORTH EAST</u> corner, the

The monumentation and marking of the corners was completed by the 19TH day of JUNE, 1989.
