To tie this claim to the Public Survey, begin at the NORTHEAST corner of Section 12, Township 35N, Range 50E, Mount Diablo Meridian, thence 780 feet SOUTH and 600 feet WEST to the northeast corner of this claim.

I claim 1500 linear feet along the course of the ledge, lode or vein, extending 200 feet from the location monument in a SOUTHEAST direction and 1300 feet in a NORTHERLY direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 4" x 4" wood monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is: Beginning at the Northeast Corner:

thence, <u>SOUTH</u> , <u>750</u> feet to the <u>EAST</u> side center,
thence, <u>SOUTH</u> , <u>750</u> feet to the <u>SOUTHEAST</u> corner,
thence, <u>WEST</u> , <u>600</u> feet to the <u>SOUTH WEST</u> corner,
thence, <u>NORTH</u> , <u>750</u> feet to the <u>WEST</u> side center,
thence, <u>NORTH</u> , <u>750</u> feet to the <u>NORTH WEST</u> corner,
thence, <u>EAST</u> , <u>600</u> feet to the <u>NORTH EAST</u> corner, the

The monumentation and marking of the corners was completed by the 22nd day of JUNE, 1989.
