I claim 1500 linear feet along the course of the ledge, lode or vein, extending 100 feet from the location monument in a EASTWARD direction and 1400 feet in a WESTWARD direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 4" x 4" (wood) monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is: Beginning at the Northeast Corner:
