Mount Diablo Meridian, thence 650 feet SOUTH and 1100  
feet EAST to the northeast corner of this claim.

I claim 1500 linear feet along the course of the ledge, lode or  
vein, extending 750 feet from the location monument in a N 32° E  
direction and 750 feet in a S 32° W direction, together with  
300 feet on each side of the center of the ledge for the entire length  
of the claim.

The exterior boundaries of this claim are clearly marked by substantial  
"4" x "4" wood monuments firmly set in the ground and bearing applicable  
monument designation. The description of such claim is: Beginning at the

Northeast Corner:  
thence, S 32° W, 750 feet to the EAST side center,  
thence, S 32° W, 750 feet to the SOUTHEAST corner,  
thence, N 58° W, 600 feet to the SOUTH WEST corner,  
thence, N 32° E, 750 feet to the WEST side center,  
thence, N 32° E, 750 feet to the NORTHWEST corner,  
thence, S 58° E, 600 feet to the NORTHEAST corner, the  
point and place of beginning.

The monumentation and marking of the corners was completed by the  
21<sup>st</sup> day of JUNE, 1989.

The location work consisted of making a claim map as provided in NRS  
517.040. Two copies of this claim map have been filed with the EUREKA  
County Recorder, and the lode claim filing fee has been paid to the County  
Recorder.
