The locator and owner is the proprietor of numerous lode claims, the Nevada Limestone Claims, all located in the Unknown Mining District:

The locator and owner has this day located 5 acres of non-mineral ground, needed by the proprietor of the above referenced lode claims, mine mill and reduction works for mining, milling, processing, beneficiation and other operations connected with such claims, mine, mill and reduction works:

This mill site claim shall be known as the M.L. NO. 45 MILL SITE.

The monumentations and marking of the above described corners and side line centers on the ground was completed within 60 days from the date of posting and the notice of location; and the location work consisted of making and recording of duplicate claim maps and payment of the fees prescribed by NRS 517.040.
