CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

To tie this claim to the Public Survey, begin at the North 1/4 Corner of Section 20, Township 26 North, Range 49 East, Mount Diablo Base and Meridian, thence South, approximately 1280 feet and West, approximately 3462 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 1,500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1,490 feet from the location monument in a North-erly direction and 10 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

thence, N.90°00'E., 600 feet to the Northeast Corner (Cor. No. 2),

thence, S.00°00'E., 750 feet to the East Side Center (Cor. No. 3),

thence, S.90°00'W., 600 feet to the Southwest Corner (Cor. No. 5),

thence, N.00°00'W., 750 feet to the West Side Corner (Cor. No. 6),

thence, N.00°00'W., 750 feet to the Northwest Corner (Cor. No. 1),

the point and place of beginning.

The monumentation and marking of the corners was completed by the 11th day of July, 1989.
