CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

He (or I) claim 1,500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1,490 feet from the location monument in a North-erly direction and 10 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:
