CERTIFICATE OF LOCATION FOR LORE MINING CLAIM

To tie this claim to the Public Survey, begin at the North 1/4 Corner of Section 20, Township 26 North, Range 49 East, Mount Diablo Base and Meridian, thence North, approximately 420 feet and West, approximately 706.2 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 1,500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1,490 feet from the location monument in a South-erly direction and 10 feet in a Northerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 3 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

the point and place of beginning.
