We (or I) claim 1,500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1,490 feet from the location monument in a North-erly direction and 10 feet in a Southerly direction, together with 100 feet on each side of the center of the ledge for the entire length of the claim.
