CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

We (or I) claim 400 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 200 feet from the location monument in an East-erly direction and 200 feet in a Westerly direction, together with 100 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 1 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

thence, S.90°00'W., 200 feet to the Southwest Corner (Cor. No. 6),

thence, N.00°00'W., 200 feet to the Northwest Corner (Cor. No. 1),

the point and place of beginning.

The monumentation and marking of the corners was completed by the 15th day of August, 1989.
