FIRST AMENDMENT TO MAGGIE CREEK MINERAL LEASE

THIS FIRST AMENDMENT TO THE MAGGIE CREEK MINERAL LEASE is made and entered into this 25<sup>th</sup> day of August, 1989, by and between Lyle F. Campbell, Willis M. Rash, Bertha C. Johnson and Jean B. Hickman, Trustees of the Lyle F. 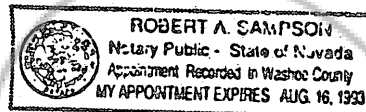
