CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, William A. Wisbet, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source through a drilled well, pump and distribution system for Irrigation and Domestic purposes. The point of diversion of water from the source is as follows: Lot 4 (SE $\frac{1}{4}$  NE $\frac{1}{4}$ ) Section 36, T.21N., R.53E., M.D.B.&M., or at a point from which the E $\frac{1}{2}$  corner of said Section 36 bears S. 45° E., a distance of 100.0 feet

situated in Eureka County, State of Nevada.

Now KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

\*This certificate changes the place of use of a portion of Permit 18621, Certificate 6233, therefore the date of priority remains the same as Permit 18621, Certificate 6233.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any and/or all sources.

The total combined duty of this certificate and any certificates issued under Permits 42890, 42891, 42893 and 44622 shall be limited to an annual duty of 439.64 acre-feet.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
