# SUMMARY REPORT

This Summary Report is filed to comply with the requirements of Title 30, United States Code, Section 28-1 for the IBM #1 through IBM #42 and IBM #44 through IBM #82 (BLM NMC Nos. 465740 through 465820), unpatented lode mining claims situated in Sections 20, 21, 28 and 29, Township 31N., Range 51E in the Safford Mining District of Eureka County, Nevada.

The work consisted of geologic mapping and sampling. Samples were analyzed for gold, silver, arsenic, antimony, mercury, copper and nickel by Chemex Labs of Sparks, Nevada.

The work was performed under the direction of R. W. Wittkopp, a geologist with twenty years experience and a degree from San Jose State University. The cost of the work exceeded \$8,100.00 and was paid for by Ruskin Developments, Inc., a joint venture partner of Pactolus Corporation, who holds these claims under lease. Results of this work have defined several anomalies.

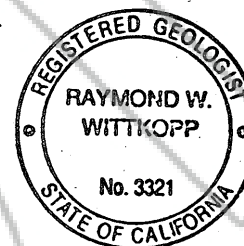
