GROUP AMENDED CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the undersigned has amended, located and claimed and by these presents does amend, locate and claim by right of original discovery and location in compliance with the General Mining Laws of May 10, 1872, as amended, and with the laws of the State of Nevada, and with local customs, laws and regulations, 1500 feet along each of the veins or lodes thereof, together with 300 feet on each side of the center of said veins at the surface and all veins, lodes, ledges or deposits and surface ground within the boundary lines of said group of claims.

With respect to this Amended Certificate of Location, the following facts are presented:

1. The names of the claims are S. J. # 1 - 16 NMC 471413 - 471428.

2. The name of the locator is amended to be Barrick Goldstrike Joint Venture.

3. The name of the present owner of the claim group is Barrick Goldstrike Mines Inc. whose address is Post Office Box 29; Elko, Nevada 89801.

4. The number of linear feet claimed in length along the course of each vein from the point of discovery of each of the claims numbered 1, 3, 5, 7, 9, 11 and 13 is 1400 feet in a Southerly direction and 100 feet in a Northerly direction; the number of linear feet claimed in length along the course of each vein from the point of discovery of each of the claims numbered 2, 4, 6, 8, 10, 12, and 14 is 100 feet in a Southerly direction and 1400 feet in a Northerly direction; and the number of linear feet claimed in length along the course of each vein from the point of discovery of each of the claims numbered 15 and 16 is 750 feet in a Southerly direction and 750 feet in a Northerly direction, together with 300 feet on each side of the center of each vein or lode for the entire length of each claim numbered 1 - 16.

5. The general course of each lode or vein, as near as may be, is Northerly and Southerly.

6. This group of claims is the same group of claims originally located by Barrick Goldstrike Mine Joint Venture on January 15, 1988, and is the same group of claims as those covered by Certificates of Location filed of record on April 4, 1988 in Book 175, pages 196-211, in the records of Eureka County, Nevada.

7. Said mining claims are located in the Northeast, Northwest, Southeast & Southwest quarters of Section 24, Township 36, Range 49 East, M.D.B.&M., and the Southeast and Northeast quarters of Section 23, said Township, in Eureka County, State of Nevada.

8. Said mining claims are situated in the Lynn Mining District, Eureka County, State of Nevada. The location monuments of said mining claims are situated in the Northeast, Northwest, Southeast & Southwest quarters of Section 24, Township 36, Range 49 East, M.D.B.&M., and the Southeast and Northeast quarters of Section 23, said Township, in Eureka County, State of Nevada.

9. The original location or discovery work consisted of making the mining claim map as provided in Nevada Revised Statutes 517.040, which map was filed on April 4, 1988 as Entry No. 117559 in the records of Eureka County, State of Nevada.

10. The location monument, corners and sideline centers for each post on each claim are at least 4 inches in diameter by 4-1/2 feet in length set 1 foot in the ground. The claim boundaries of each claim are marked as follows: Beginning at the location monument of each mining claim, thence

The claim group is bounded on the North by patented land, on the East by patented land and the Post claims and on the West by patented land and the Bazza # 10 and on the South by the Bazza claim group.

11. This Amended Certificate of Location is made for the purpose of appropriating under the mining law all ground within the boundaries herein defined and of correcting irregularities and formalities, errors or defects, if any, which may have existed or may exist in the original location, or the record thereof, and/or any prior amendment or amendments thereof, and the

record of same, and is made without waiver of any rights acquired as to the ground within the boundaries herein defined under or by virtue of said original location and any prior amended location, and to secure all the benefits of the Statutes of the State of Nevada. If said hereby amended lode mining claim should be, at any time of this Amendment, ineffective for any reason as to any of the ground within the boundaries herein defined, then as to such ground this Amended Certificate of Location shall be an Original Certificate.
