MEMORANDUM OF EXPLORATION AND MINING AGREEMENT WITH OPTION TO PURCHASE

NOTICE IS HEREBY GIVEN that MARY M. BISONI, whose mailing address is P.O. Box 152, Eureka, Nevada 89316, GENEVE BISONI, whose mailing address is P.O. Box 184, Eureka, Nevada 89316 (therin and hereinafter referred to collectively as "Optionor"), and Inter-Globe Resources Ltd., a British Columbia corporation, whose address is Suite 2120 - 650 West Georgia Street, Vancouver, B. C. Optionor has also granted to Inter-Globe the sole exclusive and irrevocable option to purchase the Subject Premises.

Any assignment of interest under the Agreement shall be made expressly subject to the Agreement and shall require the assignee to assume and agree in writing to perform all of the obligations of the assignor under the Agreement as related to the interest assigned. In case of assignment by mortgage, however, such assumption of obligations

shall not be required, but should such mortgage be foreclosed, the purchaser on foreclosure shall take subject to the Agreement. The provisions of the Agreement shall inure to the benefit of and be binding upon the parties and their successors and assigns. No assignment shall be effective as between the parties until the first day of the next month following the delivery to the non-assigning party of satisfactory evidence of such assignment.
