

# Certificate of Location of Lode Mining Claim

The claim is 1500 feet long and 600 feet wide and 20 feet is claimed in a northerly direction and 1480 feet in a southerly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the North to the South.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by a post at least 4 inches in diameter, by a ft. 6 inches in length set 1 ft. in the ground (Describe method of marking, such as "scribing the wood")

The description of each corner is as follows (describe the corner(s), such as "4x4 wooden post"):

Corner No. 1 is a NE corner, thence 750 ft. in a southerly direction to post #6  
Corner No. 2 is a NW corner, thence 750 ft. in a southerly direction to post #3.  
Corner No. 3 is a Center W. marker, 750 ft. in a southerly direction to post #4  
Corner No. 4 is a SW corner, thence 600 ft. in a easterly direction to post #5  
Corner No. 5 is a SE corner, thence 750 ft. in a northerly direction to post #6  
Corner No. 6 is a Center E. marker, 750 ft. in a northerly direction to post #7  
post #1 is the location marker.

The monumentation and marking of the corners was completed by the 18th day of Sept., 1989.

(Must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
