WARRANTY DEED AND ASSIGNMENT

THIS INDENTURE, made this 19th day of September, 1989, between GEORGE ALDO PACINI and his wife, DOROTHY PACINI (collectively "PACINI"), parties of the first part, and NEWMONT GOLD COMPANY ("NEWMONT"), party of the second part;

W I T N E S S E I H:

That the said parties of the first part, in consideration of the sum of TEN DOLLARS (\$10.00), lawful money of the United States of America, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell, assign and warrant unto the said party of the second part, and to its successors and assigns, Two-Thirds (2/3rds) of the production royalty interest reserved by the party of the first part in that certain Warranty Deed ("1987 Warranty Deed") dated as of the 4th day of September, 1987, and recorded in the Official Records of Eureka County, Nevada, on September 4, 1987, in Book 163 at Pages 141-145, which 1987 Warranty Deed reserved unto the party of the first party a THREE PERCENT (3%) Net Smelter Return ("NSR") production royalty, the definition of such being attached as Exhibit A to the 1987 Warranty Deed.

It is understood and agreed to by the party of the first

part that the effect of this Warranty Deed and Assignment is to reduce the reserved production royalty of the party of the first part (PACINI) to ONE PERCENT (1%) NSR (as defined in the 1987 Warranty Deed).

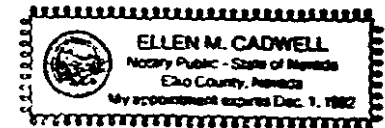
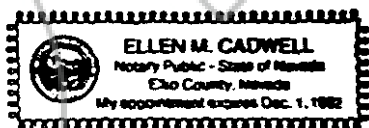
