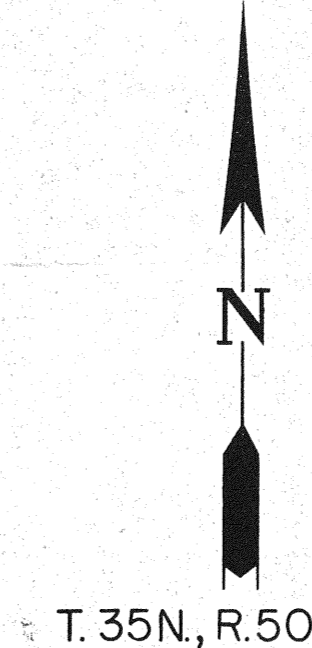
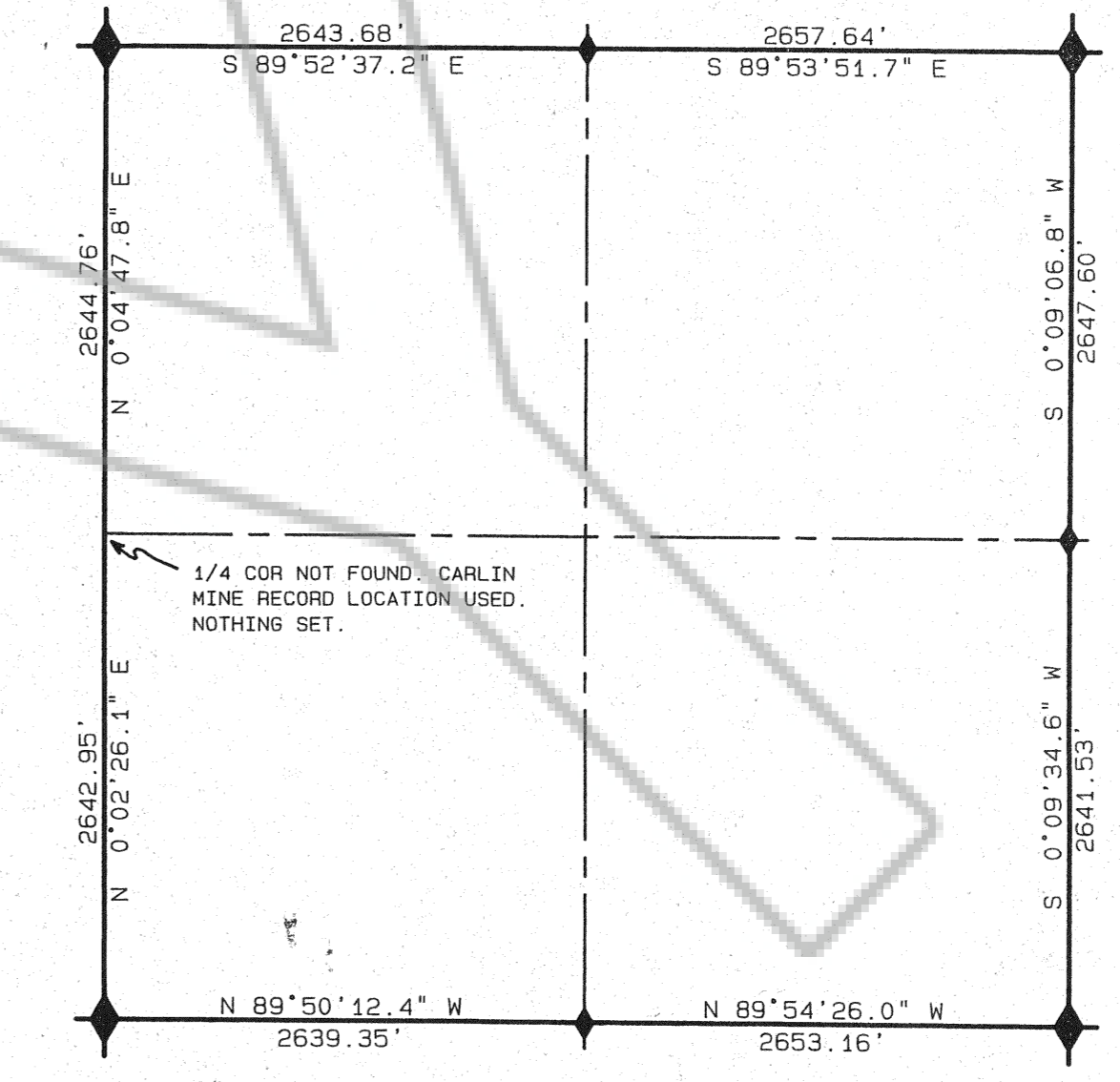
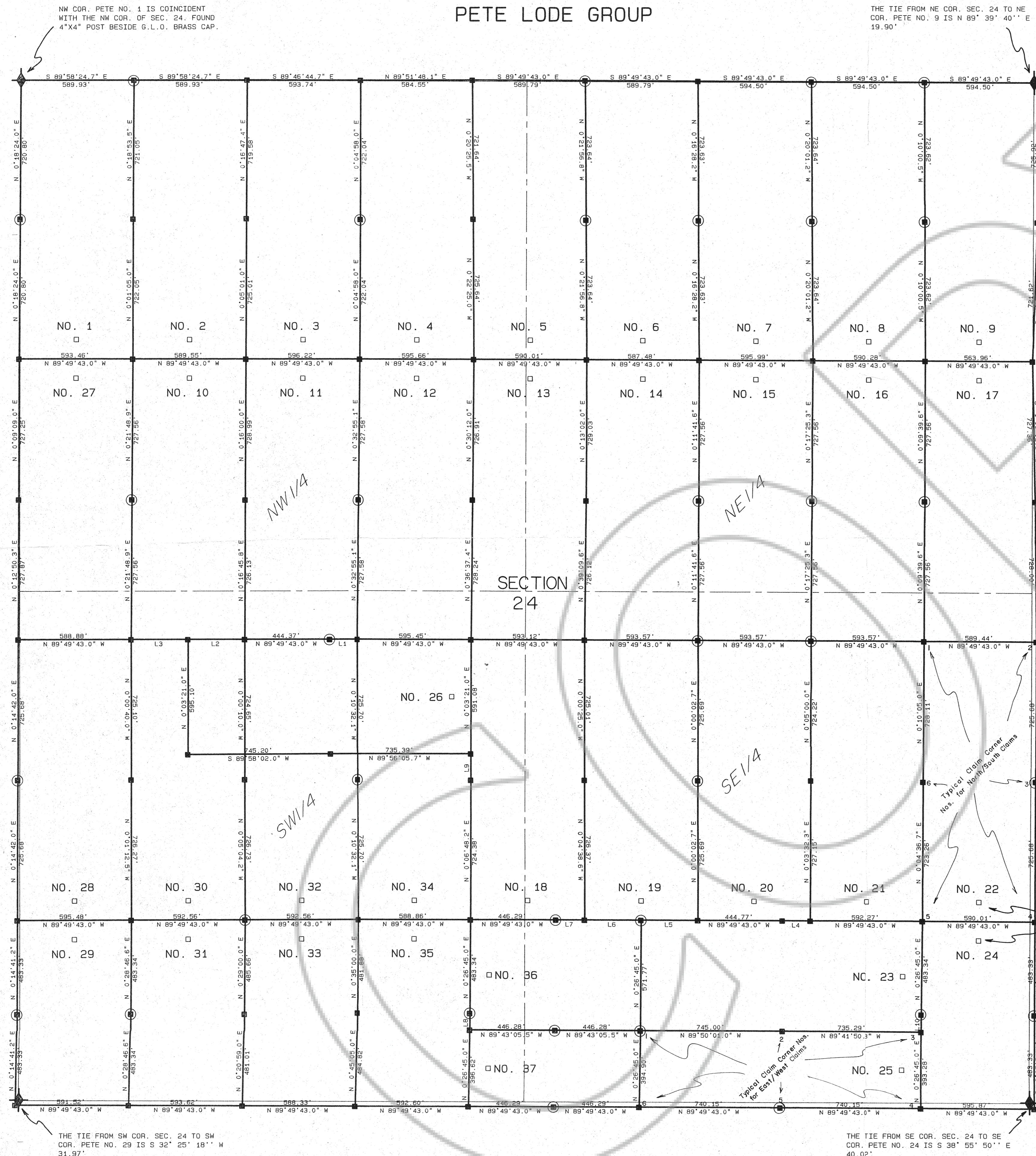


PETE LODGE GROUP
