The undersigned certifies as follows:

2. That on the 26TH day of July, 1989, pursuant to and in compliance with the mining laws of the United States and the State of Nevada, the undersigned located and claimed, and hereby locates and claims, the lode mining claim called the SIG 36 Mining Claim (the "Claim").

4. The general course of the lode or vein, as near as may be determined, is N50E and S50W.

5. The locator claims 20 feet in a N50E direction and 1480 feet in a S50W direction from the monument of location at which the Notice of Location is posted, together with 100 feet in width on each side of the center of the vein or lode.
