The undersigned certifies as follows:

2. That on the 26TH day of July, 1989, pursuant to and in compliance with the mining laws of the United States and the State of Nevada, the undersigned located and claimed, and hereby locates and claims, the lode mining claim called the SIG 50 Mining Claim (the "Claim").

3. The Claim is located in the following quarter sections:

<u>NW</u> Qtr of Section <u>12</u> , Township <u>19</u> North, Range <u>52</u> East,
<u>SW</u> Qtr of Section <u>1</u> , Township <u>19</u> North, Range <u>52</u> East,
<u>SE</u> Qtr of Section <u>1</u> , Township <u>19</u> North, Range <u>52</u> East,
<u>NE</u> Qtr of Section <u>12</u> , Township <u>19</u> North, Range <u>52</u> East,
<u>--</u> Qtr of Section <u>--</u> , Township <u>--</u> North, Range <u>52</u> East,
<u>--</u> Qtr of Section <u>--</u> , Township <u>--</u> North, Range <u>52</u> East,

M.D.B.&M., in unknown Mining District, Eureka County, Nevada.

4. The general course of the lode or vein, as near as may be determined, is N50E and S50W.

5. The locator claims 20 feet in a N50E direction and 1480 feet in a S50W direction from the monument of location at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the vein or lode.

6. The position of each corner of the Claim is shown on the mining claim map recorded herewith. The number, position and markings on each corner or side line center monument are as follows:

7. As erected on the ground, each corner and side line center monument consists of a wood or PVC post at least 3 inches in diameter by 4 1/2 feet in length, set one foot in the ground and marked as described above by metal tag.

8. The monumentation and marking of the monument on the ground were completed within sixty (60) days from the date of posting of the Notice of Location. The location work consisted of making and recording of duplicate claim maps filed herein and incorporated herein by this reference.
