4. The general course of the lode or vein, as near as may be determined, is N50E and S50W.

5. The locator claims 1480 feet in a N50E direction and 20 feet in a S50W direction from the monument of location at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the vein or lode.
