This detailed report is filed in compliance with the requirements of 30 U.S.C. S 28-1 and 43 C.F.R. S 3851.2 for those ninety-five (95) unpatented lode mining claims known as New Red Ledge Claims, et al. inclusive, situated in Sections 5, 6, 7, 8, 30, 31, 32; T27.28N; R53E; Elko and Eureka County, Nevada, which claims are more particularly described in "Exhibit A" attached hereto and made a part of and herein after referred to as "the claims".

The work has been performed between 10/10/88 and 8/31/89 by and under the direct supervision of Allen V. Ambrose, a degreed geologist from Eastern Washington University with over 10 years geologic experience.

The cost of the work exceeded \$9500 and consisted of stream sediment and soil sampling, geologic mapping, and assaying. (Note Exhibit B for locations.)

Detailed results of the work are on file at the office of H. A. Degerstrom, Inc./ R. 3303 Sullivan Road/ Spokane, WA 99216-1676.

Geology consists of sometimes brecciated Paleozoic Metasediments which have been silicified and baritized.

In summary, geochemical anomalies exist which will be grid surveyed and trenched.

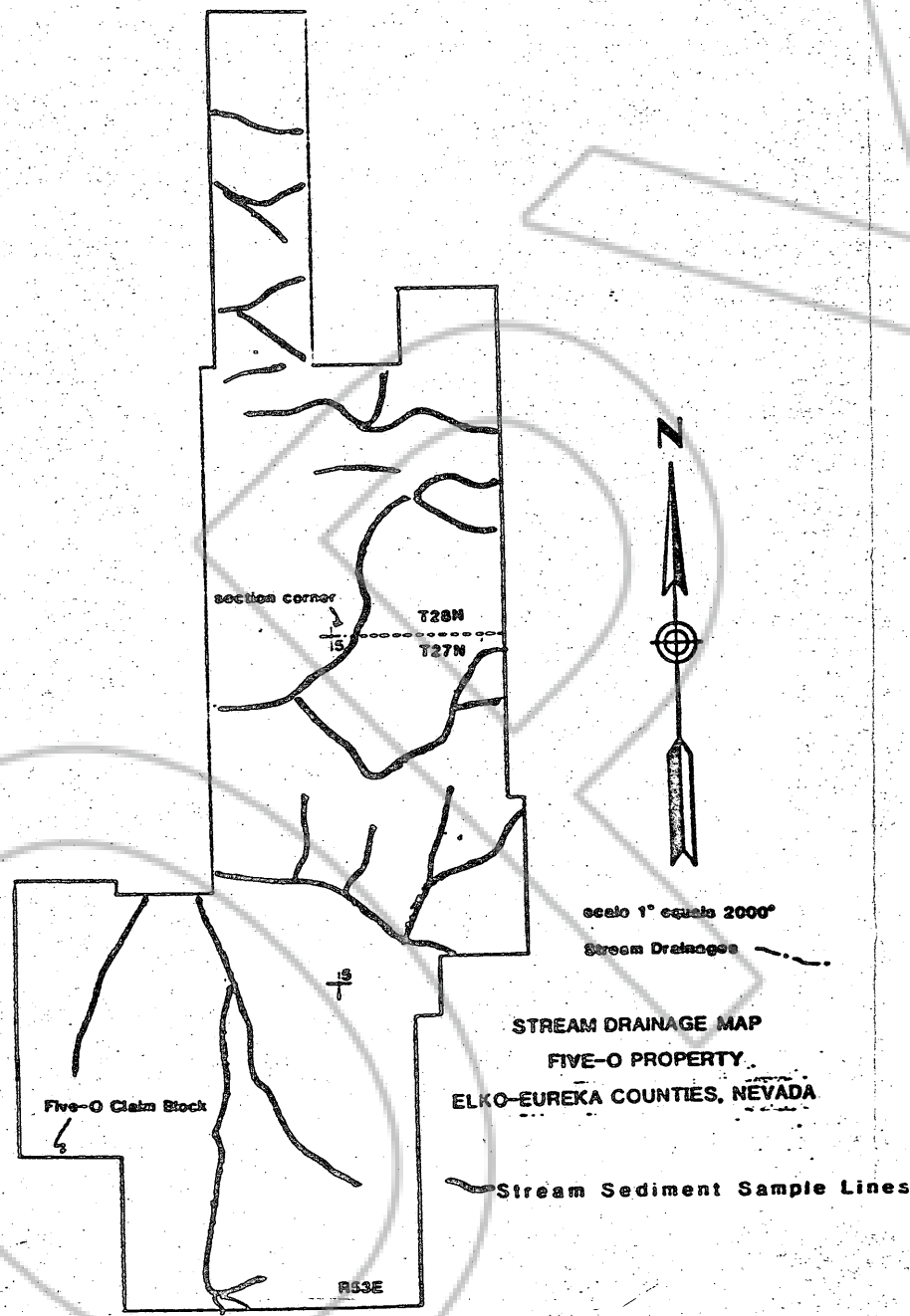
