CERTIFICATE OF LOCATION OF LOBE MINING CLAIM

Corner of this lode claim is situated 1432.98 feet in a S 10° 06' 58" W. direction from the S.E. Corner, Sec.     , T.35 N., R.49 E., M.D.B. & M., Eureka County, Nevada.
