CERTIFICATE OF LOCATION OF LODE MINING CLAIM

Corner; thence SOUTH 80.0' feet to S.E. Corner; thence N67°57'45"W 840 feet to S.W. Corner, the point of beginning. The S.W. Corner of this lode claim is situated 111.71 feet in a S65°03'36"E direction from the S.E. Corner, Sec. 3, T.35 N., R.49 E., M.D.B. & M., Eureka County, Nevada.

(d) The undersigned claim is 840 feet, linear and horizontal measurement, along the course of the vein, together with 40 feet in width on each side of the center of the vein, 25 feet of said lode running EAST from the point of discovery (designated by the location monument).
